Thank you for purchasing a Model 411 Columbia Boat Alarm.

Your Model 411 Columbia Boat Alarm was specifically designed as a boat alarm and is housed in a water resistant enclosure to protect it from water damage. The wires exiting the alarm control are marine grade wires. This alarm control is built for marine service.

ALARM OPERATION

The toggle switch is used to completely shut off the alarm. The alarm control uses a small amount of power when it is off. During long periods of storage it may be desirable to completely shut off the alarm. For the remote control to work, the toggle switch must be on. As soon as the alarm is turned on the flashing LED starts. The alarm is not active for one minute. The flashing LED should be located so that it is clearly visible outside the boat. It serves two purposes.


- 1. It informs you, the operator that the alarm is active.
- 2. Also and equally important, the flashing LED, visible from outside the boat warns the burglar that this boat is protected with an intruder alarm. This is a simple but a effective perimeter protection device. The intent is to discourage a burglar before he boards your boat and make him seek an easier target.

ALARM ZONES

This boat alarm has 3 alarm zones.

- 1. Zone 1 uses normally-closed alarm sensors. It is intended for use with the canvas snap sensors and cable wrap sensors. If an intruder unsnaps the canvas cover the alarm siren will sound. The intruder will most likely drop the canvas and run. Zone 1 will allow the siren to sound one time and then Zone 1 becomes inactive. As soon as the alarm is reset with the keyfob remote control, Zone 1 is immediately active again in one minute. (Zone 1 is the white wires that exit from the alarm control box.)
- 2. Zone 2 uses normally-closed alarm sensors. (Zone 2 has the green wires that exit from the alarm control box.) When the alarm is active and a Zone 2 sensor has been triggered, the siren will sound for two minutes. Then one minute after the siren stops. The alarm will reset. If the alarm condition still exists the siren will again sound-off. As long as the alarm control receives an alarm signal from any sensor on Zone 2, the alarm will continue to reset and the siren will sound-off for a total of 3 times. Zone 2 is designed for use with the following sensors.
 - Hatch or door sensors when the hatch of door closes automatically.
 - PIR motion sensors.
 - Or any other normally-open sensor.
- 3. Zone 3 is a normally-open zone intended for use with the pressure mat.
 - (Zone 3 has the purple wires that exit from the alarm control box.)

Note that it is absolutely necessary for the alarm system battery to be properly charged or the alarm system will **FAIL**.
